- Build leadership and teamwork skills;
- Analyze selected cases, debate legal issues and participate in both a mock trial and an oral argument;
- Gain an understanding of the real-life aspects of practicing law at a law firm or corporation;
- Develop contacts with legal professionals and organizations that provide scholarships, internships and mentors; and
- Receive guidance about the college admissions process and financial aid resources.**
